C. Teaching Innovation and Recognition

Over the past decade, I have consistently integrated innovative pedagogical approaches into my teaching practice across Business Analytics, Information Systems, and Strategy modules. I have developed new course materials, redesigned modules, and embedded experiential learning activities aligned with contemporary digital and data-driven practices.

A key area of innovation in my teaching involves the use of business simulation platforms, particularly ERPsim, for which I hold the ERPsim Certified Instructor (Level 1) qualification. This certification has enabled me to design simulation-based learning experiences that enhance student engagement, strategic decision-making, and real-time problem solving in areas such as supply chain, operations, and financial analytics. Additionally, I have extensive experience using CESIM simulations, integrating them into programme delivery at Ulster University and Coventry University to support student understanding of global market dynamics.

My practice also incorporates blended learning, flipped classroom approaches, and the use of case-based teaching, especially when delivering modules such as International Business, Global Context, and Public Health topics. I have developed several Canvas-based and Moodle-based digital learning environments, making effective use of multimedia resources, formative quizzes, and online discussion forums to maximise student engagement. I have also created

interactive materials for 7BU023 and BSU701, along with bespoke resources for computing and analytics modules.

In addition to module innovation, I have contributed to new programme development and curriculum enhancement at both the University of Wolverhampton and Coventry University. This includes designing materials for MSc Business Analytics, contributing to the Digital Knowledge Transfer agenda, and developing simulation-enabled learning activities aligned with industry needs.

My teaching excellence has been recognised through multiple avenues. I received the Best Presentation Award at the 20th Conference on Business Process Management (2017), demonstrating my ability to communicate complex analytical concepts effectively. I have also been shortlisted or invited for roles that require exceptional pedagogical skill—such as Senior Lecturer, Associate Professor positions, and Online Associate Lecturer roles—which further reflect institutional recognition of my teaching capability.

Across my career, I have maintained a learner-centred approach that supports students from diverse and non-traditional educational backgrounds, enhancing student experience and ensuring strong outcomes across my modules.
