C. Teaching Innovation and Recognition

Dr. Al Haddid has demonstrated sustained innovation in curriculum design and sustainability pedagogy, particularly through the development and delivery of the following undergraduate and postgraduate modules:

1. Sustainable Development Management

Developed as an interdisciplinary module that bridges sustainability theory with management practice, this course equips students with analytical tools to evaluate organizational contributions to the UN Sustainable Development Goals (SDGs). The module integrates systems thinking, sustainability reporting frameworks (GRI, ESG), and case studies from Jordan and the wider MENA region. Innovative teaching approaches include:

- o **Blended learning** combining interactive lectures, simulation-based sustainability decision scenarios, and reflective assessments.
- **Experiential learning** through partnerships with NGOs and local enterprises applying sustainability models in practice.
- o Integration of **SDG mapping exercises** to strengthen students' strategic understanding of sustainability performance in business contexts.
- 2. Sustainability & Social Responsibility of Entrepreneurship Organizations
 This module was designed to embed ethics, responsibility, and sustainability (ERS)
 principles within entrepreneurship education. It enables students to critically assess the
 social and environmental impacts of entrepreneurial ventures and to design business
 models with measurable social value.
 Innovations include:
 - o **Case-based learning** featuring local start-ups and global B-Corp examples.
 - o A **service-learning project**, where students collaborate with social enterprises to address real sustainability challenges.
 - o Integration of **digital storytelling and reflective journals** to cultivate responsible leadership and empathy-driven innovation.

Across both modules, Dr. Al Haddid emphasized **applied sustainability education** through real-world engagement, interdisciplinary collaboration, and the cultivation of critical, ethical decision-making skills. These teaching innovations directly support the school's mission on Ethics, Responsibility, and Sustainability (ERS) and align with EQUIS and AACSB pedagogical standards.
